Universities play a crucial role in creating knowledge and fostering democratic and sustainable societies. Their impact on wellbeing and the development of a thriving, competitive Europe stems from educating future leaders, professionals, researchers and citizens. It equally comes from curiosity-driven research aimed at identifying and meeting the broad challenges we all face and outreach to local and global industry and governments to foster much-needed innovation. Yet demonstrating and communicating universities' impact at the societal level is a challenge in itself. 13.30-15.00 **Official Opening and Plenary Session I: A central role for universities in the Europe of the future – how do we get there?**

Europe is at a crossroads, with major societal, economic and technological developments taking place and more are yet to come. Moreover, recent challenges such as Euroscepticism, post-factual politics and anti-academic movements, which often confound a university background with elitism, have consolidated concerns about the future. This session will look into the direction Europe is taking and provide reflections on how universities can contribute to building the future in a way that nudges policymakers to listen and take action.

16.30-17.30 **Plenary Session II: Head in the sand or ahead of the game? Approaches to future-proofing higher education**

Rapid societal changes impacting current and future labour markets make it essential to scrutinise and re-evaluate how university education is responding to these transformations. Through a panel discussion, this session will engage the audience to reflect on whether universities are equipping their students and staff with the right skills in the face of technological advances such as artificial intelligence. It will explore how universities prepare students to work and be active citizens in this context. The session will also ask what university leaders in particular can do to keep their institutions up to speed.

11.30-12.45 **Plenary III: Strength in numbers – can university alliances change the game?**

Strategic transnational collaboration between universities is becoming increasingly prevalent in higher education. The European Commission's European Universities Initiative, for example, has captured widespread interest by establishing bottom-up networks allowing students to obtain a degree through cross-border studies in several participating universities. This session will look into what cooperative models are in place to date, what kind of benefits and challenges they bring, and whether and how such collaboration will allow universities to increase their impact.
